**COMPREHENSIVE RESOLUTION FOR STREETS TO BE SUBMITTED TO THE
PENNSYLVANIA DEPARTMENT OF TRANSPORTATION FOR INCLUSION
IN THE COLLEGE TOWNSHIP STREET SYSTEM FOR LIQUID FUELS
TAX REIMBURSEMENT PURPOSES**

THIS RESOLUTION is made the 4th day of February, 2021, by the Council of College Township, Centre County, Pennsylvania.

BE IT HEREBY RESOLVED AND IT IS HEREBY RESOLVED by the Council of College Township to submit to the Pennsylvania Department of Transportation an extension of Persia Road with descriptions attached hereto as a part hereof as Exhibit "A.1" for inclusion as part of the system of streets for which this Township is entitled to Liquid Fuels Tax Reimbursement.

THE LOCATION AND PLACEMENT of said streets are further plotted and set forth on the street plan of this Township, as set forth in the Subdivision plots set forth as Exhibit "A.2" and made a part hereof by reference. The standards for each of said streets and their compliance with the various codes and regulations of this Township have been properly considered by the College Township Council as same were offered to the Township by the respective grantors over the period of time represented by the various Deeds, which are referenced in Exhibit "A.1".

THIS RESOLUTION is made for the purposes stated herein and so as to provide a Comprehensive Resolution by this Council to induce the Pennsylvania Department of Transportation to provide for the reimbursement of this Township under the applicable provisions of the Liquid Fuels Tax Reimbursement Laws and Regulations of the Commonwealth of Pennsylvania.
